Wellbeing Fitness Education Centre and/or its associates are committed to respecting the privacy of individuals as required under the General Data Protection Regulation (GDPR) Act.

- Business associates and trusted suppliers and contractors for the purposes of administering and managing your registration and certification and for the purposes of providing you with information, products and/or services requested by you and managing and administering such requests;
- Business associates and other trusted suppliers of goods or services for the purposes of providing you with information that Wellbeing Fitness Education Centre and/or its associates believe may be of interest to you regarding Wellbeing Fitness Education Centre and/or its associates.
- Government authorities, if legally required to do so, or if Wellbeing Fitness Education Centre and/or its associates believe necessary in connection with an investigation of any activity that is illegal or may expose Wellbeing Fitness Education Centre and/or its associates to any liability;

 Third parties in connection with any proposed merger, re-organisation, or sale of all or substantially all of Wellbeing Fitness Education Centre's business.

Your Ability to Opt-out / Opt-in
